 - b. Budget Number 658 K 8, Fall 2023 658.4 and Spring 2023 666.
 - c. Upon addressing chronic absenteeism by creating partnerships doing home visits and another new program where parents are receiving daily attendance notifications via post cards. Along with our daily phone calls home to parents of students that are absent. There has been a significant change in these numbers. Three yrs ago 38 to 40%, Two yrs ago 24 to 34% prepandemic numbers, currently 12 to 13%.
 - d. Dave Bing Foundation has program working with African American males doing skilled trades and as Parent/Guardian Mentors. We would like to reach out as it lines up with Hanley's After school skills trade class. Request possible set up with guest speakers to come in and connect with students. Mr. Leib and Mr. Brooks has contacts with the organization.
