5) Agenda Items

- A) GVSU Representative Report Cheryl Edwards-Cannon
 - a. School Performance Report snapshot of how Hanley performed in the 2022-2023 school data. State released M-Step data was combed through the end of January. Current contract length is 7 years thru 2026. Hanley's highlights as a school leader were shared with the public. The CSO Capacity Analysis Hanley International Academy demonstrated strength in its educational performance, organizational soundness and fiscal stability. It was also observed that the academy outperforms statistically similar schools as measured by the state assessment. The assessment is viable with great standings and we see no concerns.
 - a. 2022-2023 Assessment Results 2023 M-Step ELA 39%, 2023 M-Step Math 28% and 2023 M-Step All subjects 28%
 - b. Roster of statistically similar schools within a 2 mile radius. Fair comparison of schools most like Hanley in enrollment and curriculum. Test Participation rate of 97%, this is an amazing number. School Index 77.85 is in the upper tier and a good place to be. Compliance reporting condition exceeds standards at 95%.
 - c. Attendance rate at 92% very commendable, with no truancy issues.
 - d. English Language Learners on par historically.

We applaud Hanley with a very good report!

- b. CSO inviting Board members, teachers and guests. GVSU Board Reception, thanking you for your service. Held on May 13, 2024 @ The War Memorial with Janet Cohen, a native Detroiter as our guest speaker. Brooke would be delighted to resend the link for your registration.
- B) ESP School Report Steve Paddock, HIA Superintendent
 - a. Current enrollment of 709 Commendable number as families begin to travel towards the end
 of the school year. Re-enrollment, 85% of students processed 550 staying and 7 not
 returning. April 1, Open enrollment. Free/Reduced Lunch at 97% and Special Education at
 9%.
 - b. Professional Development Holding data meetings with teachers since January. This week our Admin team went to TRG's annual meeting with all of the Superintendents to present our data. We have found that the other TRG schools replicate Hanley's reporting structure. We view this as a compliment towards our leadership team..
 - c. Facility issues Vents will be cleaned during Spring Break, 3 to 4 day process. Member Szczesny asked if large increase in cleaning ventilation, Steve replied yes. President Leib asked about the Roof, Steve replied it will be a summer project, after Contractor Bid hope to get started in July.

a) Purchase of new lot update – Steve spoke with the owner who asked for 20,000. Steve told him no, can't and no offer more than 15,000. Found recently they invested 9,000 in cleaning up the property. Member Szczesny questioned condition of the City's sewers on the property. Steve said Dickenson Wright will look at the property and survey review. Steve asked allow me to speak with our attorneys and they can draw up a purchasing agreement.
